

## Terms & Conditions of Entry

### Territory Sounds Countdown | Lottery, Raffle, Game of Chance

#### METHOD OF ENTRY

1. Information on how to enter a vote and prizes form part of these conditions of entry. Voting is deemed as acceptance of these terms and conditions.
